Privacy Policy - Lidacel Limited

The Policy is designed to assist you in understanding how we collect, use and safeguard the personal information you provide to us and to assist you in making informed decisions when using our site and our products and services. This statement is updated regularly and changes will be posted on this page.

What Information Do We Collect?

When you visit our Web site you may provide us with two types of information, personal information that you choose to disclose and web site statistical information collected on an aggregate basis as our web site is accessed.

A. Personal Information You Choose to Provide

If you choose to you may send us information using the contact forms on our site. For example, you may choose to provide the following information:

Name

Surface Mailing address

Email address

Business phone number

In addition if you choose to receive our newsletter you will be asked to provide your email address. If you choose to correspond further with us through email, we may retain the content of your email messages together with your email

address and our responses.

B. Web Site Use Information

Like most commercial web sites, our web site uses an industry standard technology called "cookies" and web server logs to collect information about how our web site is used. Information gathered through cookies and web server logs may include the date and time of visits, the pages viewed and time spent on our web site as well as other information. This information is collected on an aggregate basis for statistical purposes and contains no personally identifiable information.

Cookies

Cookies are a feature of your web browser software that allows web servers to recognize the computer used to access a web site. Cookies are small pieces of data that are stored on your computer as a text file by your web browser.

A cookie is a piece of data that identifies you as a unique user. These are used to remember information such as your preferences in relation to this site, we use cookies to enhance the design of our web pages and improve your browsing experience. You may opt to switch off the use of cookies in your web browser (see your browser documentation for details of how to do this), this should not impede your use of this web site.

Web Server Logs

Web Server log files are used to log access to and from our web site and to provide statistical information.

How Do We Use the Information That You Provide to Us?

We use personal information for purposes of administering our business activities, providing services that are requested by our customers. We may use information such as email addresses to provide you with information that you have requested either directly or through your participation in our newsletter. Our newsletter is strictly optional and you may choose to subscribe or not using the form provided on the main page of this site.

Web Site Services

Occasionally, we may also use the information we collect to notify you about important changes to our site, new services and special offers we think you will find valuable.

Sharing Information

We do not share or sell information to any third parties

Links to Other Sites

We may provide links on our site to other sites such as partners or general sites that we think may be of interest to you, please note that if you use these links you will have left this site. The content and material or other links on these sites are completely outside our control.

Legal Exceptions

We may provide information when we believe the law requires us to do so and to protect our legal rights.
